

CONSIGNMENT AGREEMENT

This agreement is made on _____ between:

Spyder Arms LLC, referred to as **CONSIGNOR** agree:
(CONSIGNOR)

Whereas **OWNER** wishes to sell VARIOUS FIREARMS AND ACCESSORIES by consigning said item(s) to **CONSIGNOR** for sale, it is understood:

That the **OWNER** affirms that all items offered to the **CONSIGNOR** for sale are the legal property of the **OWNER** and they have the right to offer those items for sale.

That **CONSIGNOR** agrees to list item(s) in a prominent place(s) on the internet for sale, and perform all duties necessary to create and manage those listings. **CONSIGNOR** will also handle the collection of funds from the sale, and subsequent delivery to the buyer.

That **CONSIGNOR** will make every attempt to obtain the best possible price for the consigned merchandise and will accept no less than the RESERVE PRICE established by the **OWNER** as purchase price.

That RESERVE PRICE will be set by the **OWNER**, in writing, when offering any item for consignment sale.

That for his efforts **CONSIGNOR** is entitled to retain **15 %** of the purchase price, as well as all shipping and handling fees agreed to by the buyer.

That all firearms will remain in the possession of the **CONSIGNOR** until such time as that item has been sold, unless otherwise agreed to.

That should a sale be made, **CONSIGNOR** shall deliver a check for the amount of the full purchase price, less the aforementioned **15 %**, to **OWNER** within 10 days of the receipt of payment.

That should the merchandise remain unsold at the end of the consignment period and an election be made by the **OWNER** to remove said merchandise, any costs incurred by the **CONSIGNOR** (ie, listing fees) shall be borne by **OWNER**. *(these are generally very minimal ...a few dollars at best)*

That any item may be removed from sale by the **OWNER**, unless there are open bids for that item that exceed the RESERVE PRICE. In that case the item is considered SOLD and can not be withdrawn. If an item is removed from sale, any costs incurred by the **CONSIGNOR** shall be borne by the **OWNER**.

If the item is to be returned to the **OWNER** for any reason, they MUST complete a form 4473 and pass the NICS background check. This check will be performed without charge. If they do not pass the check, the item can not be returned and must be sold.

That the **OWNER** reserves the right to personally sell an item on consignment, provided they **FIRST** remove the item from sale as per the above paragraph.

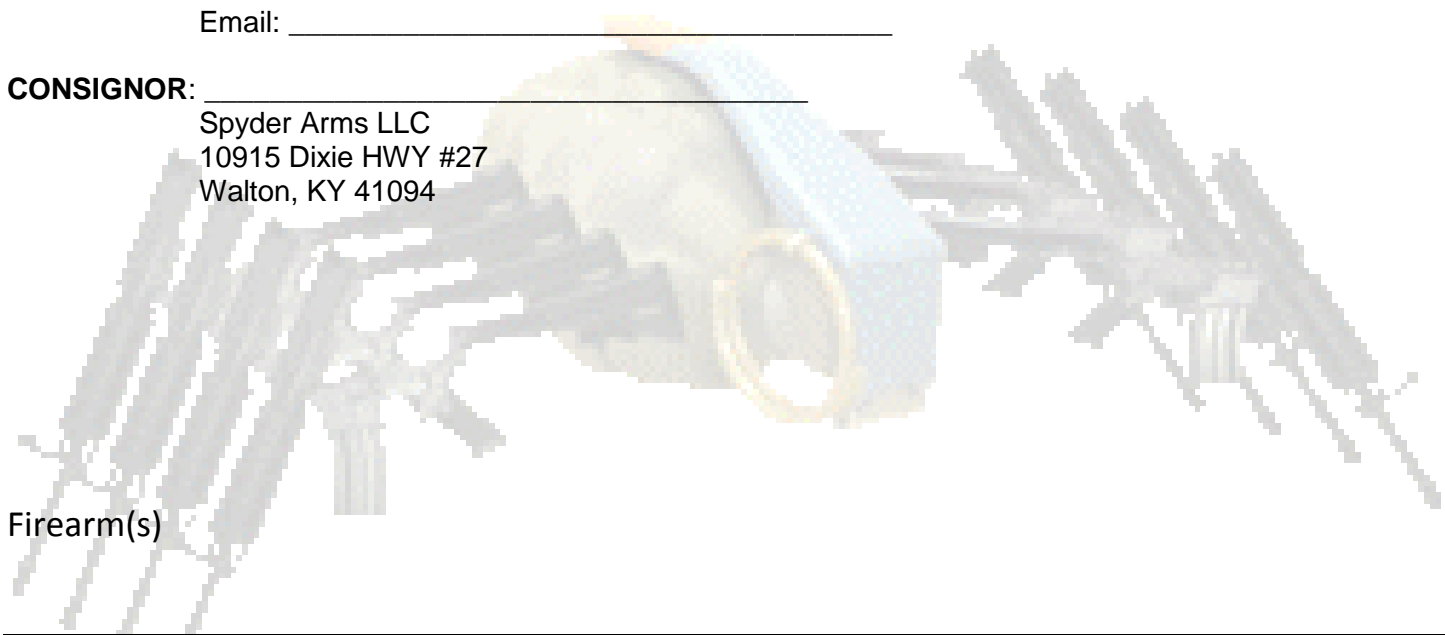
